The aim is to contribute not only to theoretical debates on the origins of capable states but also to find out where transitional states, given limited resources, should focus their efforts in recreating themselves in order to implement their own policies successfully. The investigation uses a range of qualitative and quantitative research methods including a taxpayer survey, historical research, interviews and a field study of citizen interactions with social welfare bureaucrats.
